



## RENTAL POLICY

### **BASE CUSTOMER OBLIGATIONS:**

- Provide valid driver's license
- Provide proof of full coverage insurance with a \$100k property damage policy  
**Your insurer must email the certificate of insurance showing the limits to legal@bossexotics.com before picking up the car**
- Renter will receive 100 miles per 24 hours. Miles are prorated for hourly rentals. Excess mileage is charged at \$5/per mile
- Drivers must be 21 years of age or older
- Only customer signing below may drive the rental vehicle
- Customer is responsible for rental citations, tolls, towing & storage during rental period
- Responsible for all physical and mechanical damages to rental vehicle while in their possession including 3<sup>rd</sup> party claims
- Renter may only drive the rental in the DFW area
- Must abide by all terms and conditions listed on BossExotics.com policy section
- Customer must give security deposit of at least \$1,500 to be paid by Zelle or credit card
- Renter agrees to abide by Texas driving laws and not race or speed in vehicle or lose deposit. Car may be monitored using the onboard electronic system

### **RETURN OF RENTAL VEHICLE:**

- Rental must be returned within specific rental period unless extension granted by email
- Failure to return rental by due date will result in additional charges and possible criminal charges if an extension is not authorized

### **FUEL USAGE:**

- Return fuel level must be replenished to the same level as time of rental.
- Customer will be charged \$5/gallon if fuel is not replenished.

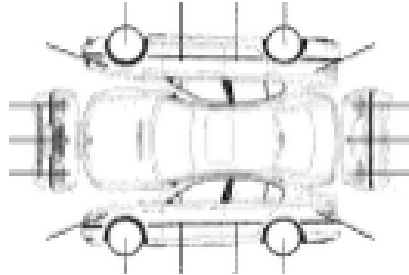
### **VEHICLE CARE:**

- Return rental in clean condition
- No pets allowed in vehicle
- No smoking allowed in vehicle
- If vehicle is not returned reasonably clean or if you violate the pet policy or smoking policy you could be charged a minimum \$499 for cleaning

You agree to all of the terms as listed in this contract. You have provided BOSS Exotics with your insurance and understand any damage caused to the vehicle while being rented or theft will be filed as a claim on your policy. BOSS Exotics does not provide insurance to renters and it is your sole responsibility to have your own full coverage insurance. You agree to report any damage or accidents to BOSS Exotics immediately. You inspected the car and agree to the rental condition above. You agree to allow BOSS Exotics to be your legal power of attorney without any limitations of any kind. This includes speaking to and conducting on your behalf any and all business dealings with any company including any insurance company and any and all potential claims without limitations including third party claims. You also allow BOSS Exotics to decide where any payments related to potential claims are to be sent and dispersed. You also admit all damages or claims that may result from this rental and authorize any payments directly to BOSS Exotics for any claims. You agree to be personally responsible for any damages not paid by your insurer. You understand that any money owed for damages can result in legal action if not paid in full. If any lawsuits arise from any accidents related to this rental, then you assume all responsibility and BOSS Exotics is immune to any pertaining liability from you and any potential third party and agree to hold us harmless. You are financially responsible for returning the vehicle in the same condition it was given to you and agree to be charged for any damages that may occur in your possession. You also agree to be liable for any loss of usage if the vehicle is damaged at the current rate of rental from the time of loss until all payments for repairs have been dispersed in full and all related repairs are completed. You understand that each day of the rental is for a 24 hour period. You will return the vehicle on the agreed due date or face possible criminal charges if an extension is not authorized by email. You agree that if any disputes were to arise related to the vehicle or this contract that you agree to waive your right to file legal suit in court and instead seek arbitration which would be at your costs only and not shared by BOSS Exotics. However, you understand that BOSS Exotics does not waive its right to file suit for any contract violations. If any lawsuits were to ever be filed then they would be filed in Dallas County only. You agree to accept any legal notices to the email listed on this contract as substitute of service instead of service by process, registered agent or certified mail. You also agree to pay for all legal fees BOSS Exotics may incur as a result of such lawsuit and waive your right to trial by jury. This serves as a non-disclosure agreement and you agree to not slander, defame or write negative reviews against BOSS Exotics if any disputes arise. This is a binding contract once signed and if you do not fulfill the terms of the contract then you are responsible for a contract violation fee of ten thousand dollars. You understand that if any legal action is needed in relation to violations of the contract that you agree to pay for all financial losses, damages, legal fees, collection fees and the contract default fee due within 30 days of notice. This contract also supersedes and voids other prior contracts between BOSS Exotics and renter and is final by signing below.
